

The General Commission of Intelligence for xxx Provence Capital and Counties of The Islamic Emarat of Afghanistan

Mr: xxxxxxx xxx, son of Hajee xxx xxx, resident of xxxxx Village of the Central County of xxx Provence; as you have been previously warned by the Islamic Emarat's Mujahideen to stop your servitude to the invading crusaders and as you rejected their warnings and continued your godless servitude and provided security to your brother, xxxxxxxx xxxx who was an interpreter for the Americans and was working with the crusaders in some camps, and as you ignored the subpoena from the Islamic Emarat, we found you guilty in absentia and sent your file to an upper Sharia Court where you shall be sentenced to death. These court decisions are final and you will not have the right to object. You chose this path for yourself and your death is eminent, God willing.
